**Explanation of Responses:**

- This transaction was executed pursuant to an Employment Agreement entered on July 8, 2019. It was executed at a price of \$22.48 per share on March 1, 2021. The 60,653 shares were issued net of taxes as the Reporting Person had the Company withhold 39,347 shares from the 100,000 share grant for taxes due.
- This number was originally reported as 427,650 in error - the Reporting Person's holdings increased by the net number of 60,653 shares and not by the 100,000 gross number.
- This transaction was executed pursuant to a 10b-5 Plan entered into on February 11, 2021.
